 - o USACE has granted permission for ownership to build 72 additional slips
 - Current slip expansion plan to maximize wait-list demand

 - o Ship store is classified as a separate entity as it holds liquor and tobacco licenses



Slip Expansion



An owner can build an additional 72 slips and leverage the in-place wait list. USACE has approved a total of 200 boat slip under the current lease and master plan. 55 of the existing 183 slips are occupied by barges which have been built out with floating homes. These 55 barge-occupied slips do not count towards the total slip count, leaving room for an additional 72 slip expansion. There is plenty of excess parking to support the slip expansion

Based on the current wait list, ownership believes that the following additional slips are in high demand.

- 48 slips @ 26'
- 24 slips @ 40'
